Dear Mr. Clark:

Thank you for your recent correspondence to the Oregon Department of Justice (DOJ), Office of the Attorney General regarding Mr. Eric Klinko. Unfortunately, Attorney General Kroger does not have jurisdiction or authority to intervene in this matter.

Oregon law prohibits the Attorney General and employees of the Department of Justice from providing legal advice to private individuals. *See* ORS 180.060. Likewise, we do not do investigations on individual matters. DOJ serves as counsel to state agencies, boards and commissions, but we are limited in our capacity to investigate, monitor, or control the activities of other state and local government agencies, including investigations by county sheriff's offices. Our office may only serve the public by enforcing Oregon's consumer protection law, regulating charitable activities, enforcing child support obligations, and providing support for victims of violent crime.

Under Oregon law, the power to conduct criminal prosecution belongs to the district attorney serving the county *where the alleged crime took place*. Although DOJ may provide assistance to the district attorney upon request, the district attorney has exclusive jurisdiction in criminal matters. I regret that our agency is limited by jurisdiction and cannot be directly helpful to this cause, but we are grateful to engaged citizens like you who take the time to correspond with us.

This letter is to acknowledge the complaint that you made against employees of the Eugene Police Department (EPD) on September 7, 2011. This office performed a preliminary investigation into your interactions with EPD on both July 18, and July 28, reviewing your complaint, the related police reports, and related in-car video (ICV). In our review, we found no evidence of:

Conspiracy to defame[;] Conspiracy to conceal ... evidence...[;] False Arrest[;] Manufacturing of Evidence[;] Deliberate timing of SWAT action to ensure maximum defaming[;] False imprisonment deliberately timed to ensure painful overnight stay[;] False police action designed to defame and pretext the next brutal abuse[;] Forcible removal from [your] home ...[;] being force=marched to a waiting line of SWAT vehicles.

To clarify, no SWAT action was taken in EPD's interactions with you; the officers who were dispatched to your home are not on the SWAT team. Therefore, this portion of your complaint is dismissed. However, we were not able to determine (through our preliminary investigation) the circumstances of you being taken to the jail without your shoes or wallet. This portion your complaint has been classified as a Service Complaint and has been forwarded to the appropriate EPD supervisor for follow up.

The remainder of your complaint, regarding human rights violations by jail personnel, falls outside of the purview of this office. Eugene City Code authorizes our office to intake and oversee the investigation of complaints related

to the conduct of Eugene Police Department employees. The jail is run by the Lane County Sheriff's Office (LCSO) and is outside of our jurisdiction. Your complaints regarding your treatment at the jail may be directed to LCSO Internal Affairs, 125 E. 8<sup>th</sup> Ave., Eugene OR 97401 or by phone at (541) 682-4399 or (541) 682-6797.

It is important that you know that we take these matters very seriously. If the Auditor's Office can be of any assistance to you, please let us know.

Dear Mr. Gissiner:

Thank you for your September 19 letter. I completely disagree with facts as you stated them. The actions of your office so far have done nothing but rubberstamp the illegal and unethical action by City of Eugene. I am possibly in workout process with Company which may provide the opportunity to put all this behind us. Until then.... we are going to civil court extremely rapidly. Here is truth. I tell the truth.

1. The police "posture" half-truths and lies. Their reports...obviously to anyone....are defaming reports, entirely based on here-say and fabricated evidence. They are designed to make a jury or judge assume there must be some sort of crime. It is of such an extreme and un-true nature that it denies me the right to a fair trial. Your office is now accomplice. Your office is now criminally implicated in racketeering, conspiracy to conceal human rights violations, etc. You personally are a criminal. You personally need to be immediately thrown in jail holding.

2. It was a SWAT Team. There were two cruisers and two SUV's. Is that typical for second degree municipal trespass 6 hours after event and without any evidence? There were two police officers who grabbed me and chained me, possibly (likely) without any legal right to do so. There was a German Shepherd police dog managed by a third officer. It was 6 pm on Friday July 28, a full 6 hours after the false trespass call-in. I consider your statement in your letter to be a lie just based upon the three officers who I saw. In the context of the allegations, anything past one Police car shortly after event was completely unnecessary, brutal, and defaming.

3. The circumstances of my wallet and shoes are exactly as I stated and written. I assume Police have an arrest event recording...they recorded all else so if they don't have that recording it would be another mystery. I have told the truth. I will not accept being treated as a liar.

4. City of Eugene is (at this moment) prosecuting completely without valid evidence. They literally made up allegations of sexual assault threat against me. The fabricated evidence to posture me as a threat. You, your office, the police, the county, the state....will all be investigated and sued. There will be absolutely no limit, no quarter, no letting up. All involved in this corporate-directed, city-operated atrocity will stand trial, pay damages to me, and when ever possible be fully prosecuted as criminals to be jailed. You will be defamed. You will be stripped of employment. You will lose your homes, your families....all because you chose to do the wrong thing in 2011 on this case. There is time to change your illegal course.

5. City of Eugene cannot pass along responsibility for what happens in its jail. City of Eugene is fully and jointly responsible for what happens there as an accomplice to the crimes that were reported and will both be highly publicized and tried in every possible civil and criminal venue. Breaking the atrocity into tiny functions is what the Nazis did. Their defense did not work at Nuremberg, many of them "hung" as will many involved in this city-operated atrocity.

The focus of the OCC's review of consumer complaints against national banks is to determine whether the banks' actions are consistent with banking statutes, regulations or any policies that are applicable to nationally chartered banking institutions.

We would like to thank you for bringing this matter to our attention. Your comments and concerns will be forwarded to our examiners as they go about their regularly scheduled examinations of the bank. This information is critically important to the OCC as we strive for a safe and sound national banking system.

The mission of the OCC is to ensure a safe, sound and competitive national banking system that support citizens, communities and the economy of the United States. To accomplish its mission, the OCC conducts regularly scheduled examinations of national banks and their affiliates. The OCC may also conduct targeted examinations as a result of information provided by the public and other independent sources. During an examination, national bank examiners may review bank operations in such areas as commercial and consumer lending, investment, and fiduciary activities. We may also assess the quality control systems employed by banks as well as the qualifications and performance of key management personnel. The information obtained during our examinations is exempt from public disclosure under Exemption 8 of the Freedom of Information Act. Exemption 8 covers matters "contained in or related to examination, operating or condition reports prepared by, or on behalf of, or for the use of . . . [the Comptroller's Office]".

Participation in Racketeering Activities of Wells Fargo Bank

This is to request an investigation of the City of Eugene Prosecutor's Office with regard to Docket Number 1113485: I hereby charge based upon police reports in subject case the following Crimes and Civil Violations of the below indicated parties:

1. City of Eugene Prosecutor's Office has continued prosecution of above case despite lack of evidence. I have written and asked for significant discovery material. Only a tiny part has been received. There is nothing but here-say and organized defaming of the worse and most flagrant fashion imaginable. There is no witness or video of the alleged event.

→ 2. City of Eugene Police/Prosecutor did actively conspire with Wells Fargo Bank and Securitas, to defame and libel and cause illegal arrest by SWAT and barbaric and unnecessary 18 hours in "jail holding". July 28, 2011. I reported detail to City of Eugene Prosecutor and Auditor significant human rights abuses in that facility. All parties are responsible including Lane County Sheriff's Office which manages the jail holding.

→ 3. City of Eugene Police/Prosecutor did actively conspire with Wells Fargo Bank and Securitas in Racketeering activities alleged of Wells Fargo in May 25 and July 27 2011. FBI filings and later Federal Court filings. Parties became the "policy arm" of Wells Fargo Bank in violation of law. That usage of police is a classic aspect of Racketeering as alleged and documented.

4. City of Eugene Police did actively conspire with Wells Fargo and Securitas on July 18, 2011 to generate an illegal "wellbeing call" that resulted in armed police in my home asking un-necessary, suspicious, and defaming questions. I own my home outright, am listed in directory, they could have called. The call was "internally generated" by the

police who had no standing to call in a highly invasive, insulting and defaming pretexting activity.

5. City of Eugene Police did actively conspire with Wells Fargo to deliberately time police action in the evening to defame. The events called into 911 relaying false and manufactured by the Securitas guard were mid-day. SWAT action (2 SUV's, 2 cruisers, and a dog) at my home was 6 hours later and designed to scare my family, my neighbors, and to defame me.

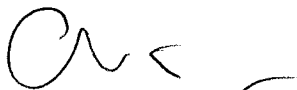
6. City of Eugene Police and Prosecutor did actively conspire with Wells Fargo and Securitas to conceal their crimes with systematic defaming and "pre-texting". For example, the self-generated illegal wellbeing call on July 18 was used as a "trespass notice" which was then used as the basis for illegal arrest and brutal jailing not fit for any mammal and most reptiles, all based on completely false information.

I saw it was not happening so I was forced to take matters into my own hands. You were in this training film asking us to report. You looked really worried and I soon saw possible reasons.

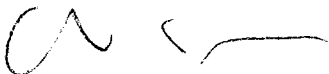
