Suggested Letter from Lane County District Attorney TO Ogletree Deakins, Leah Lively

Dear Ms. Lively:

Our local police received a violent crime threat complaint from you last week against one of our Citizens, Mr. Andrew Clark of 3270 Stoney Ridge Road, Eugene Oregon 97405.

Our Police normally do not accept personal threat complaints directly from Citizens of other jurisdictions but Citizen Clark wanted to discuss it with our Police so they could investigate. Citizen Clark did not threaten or stalk you as you alleged to our local Police. You are over 100 miles away and your local Police did not contact us with a validated threat. At this time, we consider your report to be a falsified violent threat complaint.

You furnished paperwork from civil courts and elsewhere to our Police in possible attempts to deceive Police into construing an actual threat against your Person. That aggravates possible criminal charges against you for filing the false threat report. It is evidence of a monetary or professional motivation. It gave us cause to review our records, including Police audio. Citizen Clark's removal from his home on 7.29.11 by our local SWAT/Police forces for 2<sup>nd</sup> Degree Municipal Trespass, dismissed with no hearing came to our attention.

Kidnapping requires criminal investigation and indictments against the perpetrators. There was unlawful removal from a person's home using armed forces. Our Police were not told the full truth by Wells Fargo agents at that time, either. They were lied to. That is clearly proven in the Police audio and written reports. That caused good-faith action of our Police to be the innocent tool of kidnapping. That is classic "mob style" kidnapping along with serious corruption and deception of our diligent, trusting, hardworking City of Eugene Police.

Citizen Clark provided his opinion that your Client, Wells Fargo Bank, may have been jeopardized by the situation and appropriate personnel may not be fully aware of all facts and might prefer to handle the matter outside of courts. His opinion is not relevant to us. We vigorously prosecute crime based on confirmable facts from Police Records.
